Stagebarn Contingency Proposals. Bob Burns presented the recommendations from the building committee for the contingency proposals for the Stagebarn Middle School. The committee recommended that the district approve the following contingency proposals: the buildings and grounds equipment shed, the fifth and sixth grade playground, and the sidewalk on the front of the building.

Engineering Proposal for Boiler at SWMS. Brett Burditt discussed the need to replace the boiler system at Sturgis Williams Middle School.
