Item 7d - New Attendance Center Name

Background: The District needs to submit a name change to the Department of Education. The deadline is March 1, 2019. A survey was conducted in December that provided information that was used in determining the name of the new school located at Union Center. The name selected was Central Meade County School.

Item 8a – STEM Labs

Background: Capital Outlay dollars have been allocated for two STEM labs scheduled to be online next year. One lab will be installed at the new Stagebarn Middle School and another lab will be installed at the new attendance center being built at Union Center. Mr. Simmons will explain what a STEM lab is and answer any questions.

<u>Item 8b – Graduation Requirements</u>

Background: The Department of Education adjusted state graduation requirements. High School Principal Mr. Pete Wilson will provide a brief explanation of the changes that affects the high school.

Item 8c - Strength and Conditioning Coach

Background: The superintendent was approached about the possibility of employing the services of a strength and conditioning coach to enhance the physical potential of athletes in our programs. Black Hills Orthopedic and Sturgis Regional Health brought proposals to a subcommittee for review. To engage in an agreement with Sturgis Regional Health, the school would have been required to break the existing contract with Black Hills Orthopedic. Both entities proposed quality options for consideration. The subcommittee recommends honoring the current contract that the school has with Black Hills Orthopedic. Considering there was not a change to the existing contract no board action is required. Mr. Palmer, our activities director, will continue to investigate the possibility of employing the services of a strength and conditioning coach.
