Meade County School Board:

We are requesting that the bus route on Hwy 34 (Volunteer, Bus #152, Route 6) be moved to how it once was; up 199th St. and back on Hwy 34. The route would go from Hwy 34, north on 9 Mile Road, east on 199th St and loop back to Hwy 34. The route would then go to the Belle Fourche River (like it currently does), pick up kids at 4 Mile Road then return to Sturgis picking up kids on 34 along the way. 199th St. has at least 3 families that would benefit from this route change; Studder (one 3rd grader), Casteel (one 4th grader and a 3 year old) and Komes (one 4th grader, one 3 year old and an infant). There may be more families with young children on 199th that would benefit from this route change too. Also, there is a possibility that this route change may assist families on Wetz Road as well.

9 Mile Rd. and 199th St. are very well maintained gravel roads. They are both graded by the county regularly.

We currently drive 25 miles per day (am and pm) to put our child on the bus. The requested route operated on our road for years and was only changed because there were no kids living on 199th St.

To the best of my knowledge, the below route adjustment would be correct. Our bus driver, Bob, took the liberty of driving the route and said that it doesn't necessarily change his drive times.

REQUESTED AM ROUTE:

Leave Sturgis Shop – turn right onto Lazelle/Hwy 34
Turn left on 9 Mile Road
Turn right on 199th Street
P/u at STUDDER
P/u at CASTEEL
P/u at KOMES
Turn left on Hwy 34
P/u at 145th Ave.
P/u at 4 Mile Road – cross bridge – turn around and head back to Sturgis
P/u at 142nd Ave.
P/u between 140th Ave. and 137th Pl.
P/u at 13625 SD Hwy 34 just a little before 136th Pl.
Drop off and p/u at SBHS then cross over to Ft. Meade
P/u at corner of Custer Ave. and Terry Rd.
P/u near flag pole
P/u Stepping Stone Day Care, turn left onto Lazelle
Drop off and p/u at SWMS
Drop at SES

Return to Sturgis Shop

Drop off and p/u at SWMS
Leave SWMS for Ft. Meade
Drop at Stepping Stone Day Care
Drop near flag pole
Drop at corner of Custer Ave. and Terry Rd.

Drop at Valley Implement
Turn left on Nine Mile Road
Turn right on 199th Street
Drop off STUDDER
Drop off CASTEEL
Drop off KOMES
Drop at 145th Ave.
Drop at 4 Mile Road – turn around
Drop between 142nd and 199th St.
Drop at 142nd
Drop between 140th Ave. and 137th Pl.
Drop just a little before 136th
Return to Sturgis Shop
